3. What is your personal pattern of devotional prayer and Bible study?
4. Relate your experience in determining "God's call" to the ministry.
5. What evidence have you seen of God's blessing on your ministry?
6. What strengths/weaknesses have emerged in your first years of ministry?
7. How do you define success in ministry?

### **THE HOLY SCRIPTURES**

8. Define and distinguish between revelation, inspiration, and illumination.
9. What does Scripture teach about extra-biblical revelation?
10. What is the relationship between Scripture and divine guidance?
